

**NOTICE OF SATISFACTION AND REQUEST FOR
TERMINATION AND DISMISSAL OF CONSENT DECREE**

The Wyoming Department of Environmental Quality, Air Quality Division ("DEQ/AQD"), in the name of the People of the State of Wyoming as Plaintiff, pursuant to WYO. STAT. ANN. § 35-11-901(a) (Lexis Nexis 2005) of the Wyoming Environmental Quality Act ("Act"), filed a Complaint for assessment of civil penalties against Defendant BP America Production Company, a Delaware corporation ("BP"), alleging a violation of the Act, the Wyoming Air Quality Standards & Regulations ("WAQSR") and permit no. 31-048. The Parties, by and through their respective attorneys, resolved the issues raised in the Complaint through a Consent Decree approved by the Court. BP has paid the stipulated payment required by section IV of the Consent Decree and has satisfied all other requirements of the Consent Decree. Therefore, pursuant to section V of the Consent Decree, the Consent Decree can be terminated. The DEQ/AQD hereby requests that the Court terminate the Consent Decree and dismiss this matter with prejudice.

The Wyoming Department of Environmental Quality, Air Quality Division ("DEQ/AQD"), in the name of the People of the State of Wyoming as Plaintiff, pursuant to WYO. STAT. ANN. § 35-11-901(a) (Lexis Nexis 2005) of the Wyoming Environmental Quality Act ("Act"), having filed a Complaint for assessment of civil penalties against Defendant BP America Production Company, a Delaware corporation ("BP"), alleging violations of the Act, the Wyoming Air Quality Standards & Regulations ("WAQSR"), and permit no. 31-048; and the Parties, by and through their respective attorneys, agreed to terms for resolving this litigation prior to trial without taking evidence and without an adversarial proceeding, as set forth in a Consent Decree filed with this Court on September 12, 2006. 
