

RE: Notice of Violation

Dear Ms. Salinas:

Enclosed you will find a Notice of Violation (NOV) issued to Ultra Resources, Inc. by the Department of Environmental Quality, Air Quality Division, for failing to comply with the permit requirement for routing vapors from condensate tanks to the combustor for the Warbonnet 16-4 wet gas/condensate facility located in Sublette County, Wyoming. This violation of permit CT-4032 was observed by Ms. Jennifer Frazier on June 23, 2009.

As the Department and this Division consider the failure to comply with air quality permit conditions to be a serious matter, I am considering recommending the Department refer this violation to the State Attorney General's office requesting a suit be filed in District Court to recover appropriate penalties. NOTICE OF VIOLATION

NOTICE IS HEREBY GIVEN THAT:

1. The Department of Environmental Quality, Division of Air Quality, has found Ultra Resources, Inc. to be in violation of permit CT-4032 issued in accordance with W.S. 35-11-801 of the Wyoming Environmental Quality Act and Chapter 6, Section 2 of the Wyoming Air Quality Standards and Regulations at the Warbonnet 16-4 wet gas/condensate well facility located in Sublette County, Wyoming.

2. W.S. 35-11-801(a) states, "In granting permits, the Director may impose such conditions as may be necessary to accomplish the purpose of this act which are not inconsistent with the existing rules, regulations and standards."

3. Chapter 6, Section 2 of the Wyoming Air Quality Standards and Regulations prescribes the applicability and procedures for issuing permits to sources under Wyoming's construction and modification permitting program.

4. Permit CT-4032 was issued to Ultra Resources, Inc. on August 30, 2005. Condition 12(A.) & 13 require vapors not be vented to open atmosphere. Condition 12 (A.) states:

"Upon the First Date of Production of an additional well at the Warbonnet 16-4 facility or upon the date of production associated with a well from a separate location is tied into the Warbonnet 16-4 facility, controls for emissions from all existing and new hydrocarbon liquid storage tanks and pressure vessels (flashing, standing/working/breathing losses and any separator flash gas not collected for sales) shall be installed and operational. Emission control systems or devices installed under this condition shall be designed and operated to reduce the mass content of VOCs in the gases vented to the device by at least ninety-eight percent (98) percent by weight, and shall meet the requirements of the Chapter 6, Section 2 Oil and Gas Production Facilities Permitting Guidance."

Condition 13 follows this with:

"Emission control devices installed under condition twelve (12) shall be maintained and operated during all periods of active well site operation such that each remains effective as a viable emissions control device. Records shall be maintained noting dates and durations of times during active well site operation when any emission control device is not operational."

5. On June 23, 2009, Ms. Jennifer Frazier, Air Quality Division Engineer/Inspector, observed leaking vapors venting from eight (8) thief hatches and three (3) Enardo valves. Venting vapors from thief hatches and Enardo valves and not routing vapors from the condensate tanks to the combustion device is a violation of condition 12(A.) and 13 of permit CT-4032.

6. Said violation consists of not routing vapors from condensate tanks to the combustion device. This is a violation of condition 12(A.) and 13 of permit CT-4032.

7. Under W.S. 35-11-901(a), any person who violates any provision of Article 2 of [the Environmental Quality Act] ... or any rule, regulation, standard or permit adopted pursuant to those provisions, or who violates any determination or order of the council pursuant to Article 2 of [the Environmental Quality Act] ... is subject to a penalty not to exceed ten thousand dollars (\$10,000.00) for each violation for each day during which the violation continues, a temporary or permanent injunction, or both a penalty and an injunction.

8. This notice is being sent to you pursuant to W.S. 35-11-701(c), which requires that, in any case of the failure to correct or remedy an alleged violation, the Director of the Department of Environmental Quality shall cause a written notice to be issued and served upon the person alleged to be responsible.
