RE: Notice of Violation

Dear Ms. Diamond:

Enclosed you will find a Notice of Violation (NOV) issued to Wyoming Medical Center by the Department of Environmental Quality, Air Quality Division, for failing to permit boiler unit B-03 prior to operation at the hospital in Casper, Natrona County, Wyoming. This is a violation of Chapter 6, Section 2(a)(i) of the Wyoming Air Quality Standards and Regulations. This violation was noted by Mr. Jeff Hancock on March 26, 2013.

As the Department and this Division consider the failure to comply with air quality permit conditions to be a serious matter, I am considering recommending the Department refer this violation to the State Attorney General's office requesting a suit be filed in District Court to recover appropriate penalties. If you would like to discuss settlement of this Notice of Violation prior to referral to the Attorney General's office, please contact Ms. Karen Godman, Air Quality Compliance Program Principal, at 307-777-8601 no later than ten (10) days after receipt of this letter.

**NOTICE OF VIOLATION**

**NOTICE IS HEREBY GIVEN THAT:**

1. The Department of Environmental Quality, Division of Air Quality, has found Wyoming Medical Center to be in violation of W.S. 35-11-801 of the Wyoming Environmental Quality Act and Chapter 6, Section 2(a)(i) of the Wyoming Air Quality Standards and Regulations (WAQSR) for the hospital facility located in Casper, Natrona County, Wyoming.

2. W.S. 35-11-801(a) states, "In granting permits, the Director may impose such conditions as may be necessary to accomplish the purpose of this act which are not inconsistent with the existing rules, regulations and standards."

3. Chapter 6, Section 2 of the WAQSR prescribes the applicability and procedures for issuing permits to sources under Wyoming's construction and modification permitting program.

4. Chapter 6, Section 2(a)(i) of the WAQSR states "Any person who plans to construct any new facility or source, modify any existing facility or source, or to engage in the use of which may cause the issuance of or an increase in the issuance of air contaminants into the air of this state shall obtain a construction permit from the State of Wyoming, Department of Environmental Quality before any actual work is begun on the facility."

5. On March 26, 2013, Mr. Jeff Hancock, Air Quality Division Engineer/Inspector noted that boiler unit B-03 was put into operation September 2012 and operated for 40 hours before leaking coils and valves forced the unit to be shut down. The presence of an unpermitted boiler is a violation of Chapter 6, Section 2(a)(i) of the WAQSR.


6. Said violation consists of failing to obtain an air quality permit for boiler unit B-03 at the Wyoming Medical Center, which is a violation of Chapter 6, Section 2(a)(i) of the WAQSR.

7. Under W.S. 35-11-901(a), any person who violates any provision of Article 2 of [the Environmental Quality Act] ... or any rule, regulation, standard or permit adopted pursuant to those provisions, or who violates any determination or order of the council pursuant to Article 2 of [the Environmental Quality Act] ... is subject to a penalty not to exceed ten thousand dollars (\$10,000.00) for each violation for each day during which the violation continues, a temporary or permanent injunction, or both a penalty and an injunction.

8. This notice is being sent to you pursuant to W.S. 35-11-701(c), which requires that, in any case of the failure to correct or remedy an alleged violation, the Director of the Department of Environmental Quality shall cause a written notice to be issued and served upon the person alleged to be responsible.
