RE: Notice of Violation

Dear Ms. Semborski:

Enclosed you will find a Notice of Violation (NOV) issued to ConocoPhillips Company by the Department of Environmental Quality, Air Quality Division, for failing to comply with permit requirements for routing vapors to the emission control device and venting vapors at the Spirit of Radio 7-1H facility, located in Sweetwater County, Wyoming. These are violations of permit CT-13498. These violations were observed by Mr. Travis Guthrie on April 15, 2014.

As the Department and this Division consider the failure to comply with air quality permit conditions to be a serious matter, I am considering recommending the Department refer this violation to the State Attorney General's office requesting a suit be filed in District Court to recover appropriate penalties. If you would like to discuss settlement of this Notice of Violation prior to referral to the Attorney General's office, please contact Ms. Ann Shed, Air Quality Compliance Program Principal, at 307-777-8601 no later than ten (10) days after receipt of this letter.

**NOTICE OF VIOLATION**

**NOTICE IS HEREBY GIVEN THAT:**

1. The Department of Environmental Quality, Division of Air Quality, has found ConocoPhillips Company to be in violation of permit CT-13498. This permit was issued in accordance with W.S. 35-11-801 of the Wyoming Environmental Quality Act and Chapter 6, Section 2 of the Wyoming Air Quality Standards and Regulations for the Spirit of Radio 7-1H facility located in Sweetwater County, Wyoming.

2. W.S. 35-11-801(a) states, "In granting permits, the Director may impose such conditions as may be necessary to accomplish the purpose of this act which are not inconsistent with the existing rules, regulations and standards."

3. Chapter 6, Section 2 of the Wyoming Air Quality Standards and Regulations prescribes the applicability and procedures for issuing permits to sources under Wyoming's construction and modification permitting program.

4. Permit CT-13498 was issued to Anadarko E&P Onshore, LLC on August 31, 2012 for the Spirit of Radio 7-1H facility. Condition 17 requires control of emissions as follows:

"Emission control equipment, including the VOC and HAP emission control system or device, all vent lines, connections, fittings, valves, relief valves, hatches or any other appurtenance employed to contain and collect vapors and transport them to the emission control system or device, shall be maintained and operated during any time the well is producing such that the emissions are controlled at all times..."

5. On April 15, 2014, Mr. Travis Guthrie, Air Quality Division Engineer/Inspector, observed that vapors were venting from a leaking thief hatch. Venting vapors and not routing vapors to the emission control device are violations of condition 17 of permit CT-13498.

6. Said violations consist of venting vapors and not routing vapors to the emission control device at the Spirit of Radio 7-1H facility located in Sweetwater, Wyoming. Venting vapors and not routing vapors to a control device are violations of permit CT-13498.

7. Under W.S. 35-11-901(a), any person who violates any provision of Article 2 of [the Environmental Quality Act] ... or any rule, regulation, standard or permit adopted pursuant to those provisions, or who violates any determination or order of the council pursuant to Article 2 of [the Environmental Quality Act] ... is subject to a penalty not to exceed ten thousand dollars (\$10,000.00) for each violation for each day during which the violation continues, a temporary or permanent injunction, or both a penalty and an injunction.

8. This notice is being sent to you pursuant to W.S. 35-11-701(c), which requires that, in any case of the failure to correct or remedy an alleged violation, the Director of the Department of Environmental Quality shall cause a written notice to be issued and served upon the person alleged to be responsible.
