
**ORDER TERMINATING CONSENT DECREE AND DISMISSING WITH  
PREJUDICE**


The Wyoming Department of Environmental Quality, Air Quality Division (DEQ/AQD), in the name of the People of the State of Wyoming as Plaintiff, pursuant to Wyo. Stat. Ann. § 35-11-901(a) of the Wyoming Environmental Quality Act (Act) filed a Complaint for assessment of civil penalties against Defendant, MWE Services, Inc., doing business as Midwest Demolition Company (Midwest), alleging violations of the Act and the Wyoming Air Quality Standards and Regulations (Air Quality Rules) during the demolition, renovation, and asbestos waste disposal activities at Lingle-Fort Laramie High School and Southeast High School, located in Goshen County. The Parties, by and through their respective attorneys, agreed to terms for resolving this litigation prior to trial without taking evidence and without an adversarial proceeding, as set forth in a Consent Decree filed with this Court on August 20, 2015. This Court received notice from

DEQ/AQD that Midwest has fully complied with the terms of the Consent Decree. It is therefore **ORDERED, ADJUDGED, AND DECREED** that:

Midwest has complied in all respects with the Consent Decree. Accordingly, pursuant to and consistent with the provisions of Section V thereof, the Consent Decree is hereby terminated and the matter is dismissed with prejudice. Each party shall bear its own costs and attorneys' fees.
