NOTICE

NOTICE IS HEREBY GIVEN THAT:

1. Notice of Violation (NOV) is being sent to you pursuant to Wyoming Statute §35-11-701(c)(i) which requires that a written notice shall be issued in the case of failure to correct or remedy an alleged violation.
2. The WDEQ/LQD Noncoal Rules and Regulations, Chapter 3, Section 2(c)(i)(D) states that topsoil stockpiles shall be marked with a legible sign containing letters not less than six inches high on all approach roads to such stockpiles. Said signs shall contain the word "topsoil"...
3. During the inspection performed on September 22, 2011, Mr. Schellinger documented that three topsoil stockpiles at the permit were not identified by topsoil signs.
4. The WDEQ/LQD Noncoal Rules and Regulations, Chapter 3, Section 2(c)(i)(A) states that all topsoil or approved surface material shall be removed from all areas to be affected in the permit area prior to these areas being affected unless otherwise authorized by the Administrator. The topsoil may be mixed with the subsoil but shall be segregated so as not to become mixed with spoil or waste material, stockpiled in the most advantageous manner and saved for reclamation purposes.
5. During the inspection performed on September 22, 2011, Mr. Schellinger documented that a topsoil stockpile located on the northwest pit area had been constructed in such a close proximity to the pit operations that it was disturbed by mining, and had partially eroded into the pit. The western end of this stockpile was also placed in contact with processed materials during the removal of the processed material from the pit.
6. Wyoming Statute §35-11-901(a) provides that any person who violates any provision of the Environmental Quality Act or any rule, standard, permit, license or variance adopted hereunder is liable to a penalty of ten thousand dollars (\$10,000.00) for each day of violation, which penalty may be recovered in a civil action brought by the Attorney General in the name of the People of the State of Wyoming.

NOTHING IN THE NOTICE shall be interpreted to in any way limit or contravene any other remedy available under the Environmental Quality Act, nor shall this NOV be interpreted as being a condition precedent to any other enforcement action.
