NOTICE OF VIOLATION

AND

ORDER

NOTICE IS HEREBY GIVEN THAT:

1. Daren Singer owns and operates an aboveground storage tank (AST) that is used to sell fuel retail at Edelweiss, storage tank facility 0-004129, which is located at 2900 Highway 120, near Clark, Wyoming.
2. Daren Singer has not performed a minimum site assessment (MSA) and has not upgraded the AST at Edelweiss.
3. The DEQ has determined that the following violations of Wyoming Water Quality Rules and Regulations (WWQRR), Chapter 17, have occurred at Edelweiss:

**Count 1: Failure to Perform an MSA [WWQRR, Chapter 17, Section 29(a)(i)].** As owner of an AST, Daren Singer is in violation of WWQRR, Chapter 17, Section 29(a)(i), for failure to perform an MSA by October 1, 2008.

**Count 2: Failure to Upgrade an AST [WWQRR Chapter 17, Section 35(o)].** As owner of an AST, Daren Singer is in violation of WWQRR Chapter 17, Section 35(o), for failure to upgrade the AST by October 1, 2008.

4. Any person who violates any provision of the Environmental Quality Act, or any rule, standard, permit, license, or variance adopted thereunder, is liable for a penalty of ten thousand dollars (\$10,000.00) for each day of violation, which penalty may be recovered in a civil action brought by the Attorney General in the name of the people of Wyoming.
5. This Notice is being sent to you pursuant to W.S. 35-11-701(c)(i), which requires that in any case of the failure to correct or remedy an alleged violation, the director of the Department of Environmental Quality shall cause a written notice to be issued and served upon the person alleged to be responsible.

ORDER

BEFORE THE ENVIRONMENTAL QUALITY COUNCIL-STATE OF WYOMING

WHEREFORE IT IS HEREBY ORDERED THAT:

1. Daren Singer return the facility into compliance with WWQRR, Chapter 17 and perform an MSA as described within 90 days of receipt of this NOV.
2. This is a Red Tagging Order. Immediately after receiving this Notice and Order, Daren Singer is hereby prohibited from purchasing any fuel for delivery to the registered retail AST at storage tank facility 0-004129, Edelweiss, located at 2900 Highway 120, near Clark, Wyoming. All fuel suppliers are ordered not to deliver any fuel to this tank until notified by the department that this order has been lifted. The order will be lifted when:
  - a. Daren Singer has upgraded the AST in accordance with WWQRR, Chapter 17 Part I, and has performed an MSA in accordance with WWQRR, Chapter 17 Section 29.

OR

- b. Darin Singer has permanently closed the existing AST in accordance with WWQRR, Chapter 17 Section 31(b).


OR

- c. Darin Singer has changed the service of the existing AST in accordance with WWQRR, Chapter 17 Section 33(c).

THIS ORDER is final unless, not later than ten (10) days after the date this notice is received, it is appealed by filing a written petition for a hearing before the Environmental Quality Council. If a hearing is requested, the petition shall be mailed to the Chairman, Wyoming Environmental Quality Council, Room 1714 Herschler Building, 1st Floor West, 122 West 25th Street, Cheyenne, Wyoming 82002. The second petition shall be mailed to the Director, Wyoming Department of Environmental Quality, Herschler Building, 4th Floor West, 122 West 25th Street, Cheyenne, Wyoming 82002. Both petitions must be sent by certified mail, return receipt requested.

NOTHING IN THIS ORDER shall be interpreted to in any way limit or contravene any other remedy available under the Environmental Quality Act, nor shall this Order be interpreted as being a condition precedent to any other enforcement action.
