

**RE: Notice of Violation, Docket Number 5127-13
Discharge of Pollution Threatening Waters of the State**

Dear Ms. Jackson:

Attached is a Notice of Violation and Order, Docket Number 5127-13, issued to you for the discharging of pollution that threaten the surface and groundwater of the state in violation of Wyoming Statute 35-11-301(a)(i).

ANY APPEALS TO THE ENVIRONMENTAL QUALITY COUNCIL FROM THE ATTACHED ORDER MUST BE MADE IN WRITING WITHIN THE TEN (10) DAY TIME LIMIT PRESCRIBED BY W.S. 35-11-701(c). Chapter I, Section 3 of the Department of Environmental Quality Rules of Practice and Procedure (<http://soswy.state.wy.us/RULES/5675.pdf>) sets forth the requirements for the initiation of appeal proceedings.

To appeal this Order and request a hearing, you must file two (2) copies of your written petition. The first petition shall be mailed to the Chairman of the Environmental Quality Council at Room 1714, Herschler Building, 1st Floor West, 122 West 25th Street, Cheyenne, Wyoming 82002. The second petition should be sent to Todd Parfitt, Director, Wyoming Department of Environmental Quality, Herschler Building, 4th West, 122 West 25th Street, Cheyenne, Wyoming 82002. Both petitions must be sent by certified mail, return receipt requested.

NOTICE OF VIOLATION AND ORDER

NOTICE IS HEREBY GIVEN THAT:

1. Shawna Jackson resides at 111 Bomber Mountain Road located in NE ¼ of Section 8, Township 50 North, Range 73 West in Campbell County, Wyoming.
2. On October 29, 2012 Karen Farley (Karen), the Northeast District engineer, received a call from Keith Bowar of the Campbell County Building Department asking for assistance to resolve an apparent illegal discharge from a camper/RV located at 111 Bomber Mountain Road.
3. A neighbor to the residence at 111 Bomber Mountain Road called Karen expressing concern over the discharge because of wells in the area and possible groundwater contamination.
4. On November 8, 2012 a letter of violation (LOV) was issued to the residence at 111 Bomber Mountain for discharging pollution without a permit. The LOV was returned unsigned.
5. On January 17, 2013 the Campbell County Building Department verified that the RV and discharge pipe were still there.
6. Allowing the discharge of pollution or waste that threatens the surface and groundwater of the state is a violation of Wyoming Statute § 35-11-301(a)(i).
7. This Notice is being sent to you pursuant to W.S. 35-11-701(c)(i), which requires that in any case of the failure to correct or remedy an alleged violation, the Director of DEQ shall cause a written notice to be issued and served on the person alleged to be responsible.

Order

BEFORE THE ENVIRONMENTAL QUALITY COUNCIL-STATE OF WYOMING

WHEREFORE IT IS HEREBY ORDERED THAT Shawna Jackson:

1. Shall cease the discharge from the RV parked at her residence within fifteen (15) days after the date of receipt of this NOV and Order.
2. Shall submit an application to Campbell County for the construction of a small wastewater system.
3. The discharge from the RV shall be treated by the small wastewater system prior to any subsurface discharge.


This ORDER is final unless, not later than ten (10) days after the date of this notice is received it is appealed by filing two written petitions for a hearing before the Environmental Quality Council. If a hearing is requested, the first petition shall be mailed to: Chairman, Wyoming Environmental Quality Council, Room 1714 Herschler Building, 1st Floor West, 122 West 25th Street, Cheyenne, Wyoming, 82002. The second petition shall be mailed to: Director, Wyoming Department of Environmental Quality, Herschler Building, 4th Floor West, 122 West 25th Street, Cheyenne, Wyoming, 82002. Both petitions must be sent via certified mail, return receipt requested.

NOTHING IN THIS NOTICE OF VIOLATION (NOV) AND ORDER shall be interpreted to in any way limit or contravene any other remedy available under the Environmental Quality Act, nor shall this NOV be interpreted as being a condition precedent to any other enforcement action.
